The City of Hallsville, Missouri was incorporated as a fourth Class City in 1957. The City is governed by a Mayor-City Administrator- Aldermen form of government. The Mayor is elected at-large for a two-year term. The Mayor is the official head of the City and can only vote on matters in the event of a tie.

Members of the Board of Aldermen are elected from their respective wards, with two members elected from each ward. Ward 1 is North of Rt. OO, West on 124, North on Bertie and West to Rt. U. Ward 2 is everything south. The members of the Board of Aldermen are elected for two-year terms and that Board is the policy making body of the City government.

The City of Hallsville provides water, sewer and street maintenance through its Public Works Department. The City of Hallsville contracts trash service and offers curbside trash pick-up. Residents may take advantage of weekly curbside recycling by picking up clear recycling bags at City Hall, at no cost and setting their recyclables out Thursday evening each week or they may leave recyclables in the recycling bin at the Hallsville Community Center. There is also bulky trash pick-up the third Wednesday of each month.

The departments and offices of the City of Hallsville are as follows: Office of the Mayor, Office of the City Administrator, Public Works Department, and the Hallsville Police Department. The services offered by these offices and departments will be discussed later in this handbook.

The City of Hallsville, operating within its Board of Aldermen form of government, stays very responsive to the citizens of this community. The goal of our elected officials is to be a form of government by the people and for the people.

## City Offices and Departments

### **Office of the Mayor** (Telephone: 573-696-3885)

The Mayor is the Chief Executive Officer of the City of Hallsville. His or her duties include leading the Board of Aldermen meetings and when needed voting to break ties; attending meetings and gatherings to provide representation for our community and elected officials.

### **Office of the City Administrator** (Telephone: 573-696-3885)

The Office of the City Administrator is comprised of the City Administrator/City Clerk and a Deputy Clerk. This office provides building applications to builders; accepts city utility payments; issues pet licenses; offers Notary Public; faxing and copying services to the community; is responsible for the handling of city funds; and providing decision-making services for the various departments when needed. This office also takes messages and relays them to the appropriate department heads.

### **Public Works Department** (Telephone: 573-696-3885)

The Public Works Department is responsible for the maintenance of the public water and sewer system and for the maintenance of all city owned utilities, setback checks before dirt work is done on construction sites and provides inspections for sewer and water mains.

### **Hallsville Police Department**

(Non-Emergency: 311, Emergency: 911)

The Hallsville Police Department consists of a Police Chief and three two full time Officers. The department is responsible for the public safety of our community. They also investigate criminal matters and enforce violations of federal, state and municipal codes and statutes. The department maintains a visible presence and strives to protect and serve the community at large.

## Summary of Municipal Ordinances

### ***Pet Ordinances***

The City of Hallsville requires a license for all dogs and cats over the age of six months. Pet owners must show proof of an up-to-date rabies vaccination and pay a fee of \$3.00/year for those pets spayed/neutered and \$5.00/year for pets that have not been spayed/neutered. Municipal ordinance requires that the issued license be placed on the pet's collar. This allows the City to locate the owner should the police department pick up the pet. Pet tags are renewed in August of each year. Any person violating, neglecting or refusing to comply with the requirement to purchase a City animal license shall pay an additional fee of twenty-five (\$25.00) dollars at the time the license exceeds 60 days past one (1) year. Dogs running at large are prohibited. If your dog is picked up or turned into the Police Department for running at large there is a boarding cost of fifty dollars (\$50.00) for each day. The fee is in effect at the moment of collection of the dog(s) and is in addition to the citation the owner will receive upon claiming of the animal.

Barking, annoying dogs are not allowed. Ordinances also require proper food and water, proper shelter from the elements, and proper care of pets. A maximum number of four pets (cats, dogs, or cats and dogs) are allowed per household.

### ***Public Nuisances***

The City of Hallsville has a comprehensive public nuisance ordinance designed to protect the rights of property owners within our city by prohibiting certain actions that would create unacceptable conditions for surrounding area residents. A complete copy of this ordinance is available for viewing at City Hall.

The following is a short list of some of the areas affected by this ordinance. All motor vehicles must be currently licensed. Accumulations of trash, leaves, grass, or other items are not allowed. No outside storage of appliances. No maintaining any odor emitting substance and no outside bathrooms are allowed. Pools of water are not allowed, nor is the growth of grass and weeds allowed to exceed 7 inches in height.

### ***Other Ordinance Information***

The City of Hallsville has ordinances regulating the maximum speed allowed on its streets. That information is posted on street signs. Loud, excessive, unnecessary noise is not allowed. The City has ordinances dealing with a number of criminal violations such as stealing, property damage, trespassing, assault and possession of marijuana and possession of drug paraphernalia.

### Hallsville Municipal Court

Trash rates are \$15.05 a month.

### **City of Hallsville Water, Sewer, and Trash Services**

Bills are due by the 10<sup>th</sup> of each month. A **5%** late fee is assessed on the 11<sup>th</sup>. Accounts that are not paid by the 20<sup>th</sup> of the month will be assessed a **\$35.00** non-payment fee and services will be subject to disconnection. To restore service the City shall require all past due fees, interest, and non-payment fees paid in full. In addition, a fee of **\$25.00** for having such service restored during regular business hours from 8:00 a.m. to 5:00 p.m. each working day, Monday through Friday. You can pay your City bill by coming into City Hall with cash, check or a debit/credit card. There is a night deposit box where you can leave your payment, we take debit/credit cards over the phone, or you can pay your account online (Hallsvillemo.org) with a debit/credit card with your account number. If you would prefer to pay your bill through ACH (automatic payment withdrawals from your bank account) we would be happy to provide you with an application to set up your payments.

### **Daniel Boone Bookmobile**

The bookmobile serves Hallsville the 2<sup>nd</sup> and 4<sup>th</sup> Tuesday every month. The bookmobile parks in the City Hall parking lot and is open from 2:00 P.M. – 7:00 P.M.

### **Civil Defense Siren Testing**

### **Tribble Park**
