From Mayor Carter



Last month, Representative Cheri Toalson-Reisch presented an end of Legislature Report. During this report, the Wayfair Bill was mentioned as failing to pass due to a Covid shortened session. The Wayfair Bill would allow the state to automatically collect a use tax for each municipality.

I personally am in favor of a use tax in our city and would like to share more information about it.

What Is A Use Tax? In the simplest terms, a use tax is a sales tax imposed on the purchase of goods by Missouri residents from out-of-state vendors. The use tax is applied to the same type of products subject to traditional sales tax. The difference is where the goods are purchased and shipped. When individuals make purchases at retail stores in Missouri, they pay the sales tax that is applicable at that location. On the other hand, purchases by Missouri residents from out-of-state vendors that are shipped to Missouri are subject to a use tax. The state use tax rate is 4.225 percent, the same as the sales tax rate. Cities and counties may impose an additional local use tax. The amount of use tax due on a transaction depends on the combined (local and state) use tax rate in effect at the Missouri location where the tangible personal property is delivered. While the sales tax rate is based on the point of sale, the use tax rate is determined based on the point of delivery.

What If I Buy Something From A Missouri Retailer Using The Internet; Will The Use Tax Apply? No. The use tax does not apply to purchases made by Missouri residents from a Missouri retailer. The use tax applies to purchases from out-of-state vendors only. (Think Amazon, Wayfair, Overstock, etc) If a Missouri resident buys a product from a Missouri vendor over the Internet, the sales tax based on the vendor's location would apply to the purchase.

What Does This Mean For Hallsville? It would even the playing field with our local businesses and online out-of-state retailers. For years, the amount of online ordering has increased, while local brick-and-mortar retail has decreased. This affects local sales tax generation and services our municipality can provide. By gaining a Use Tax, there would be no additional tax benefit to shopping online, giving our locally operated businesses an advantage. Through the State of Missouri's models, if our voters were to approve a Use Tax, Hallsville would gain approximately \$21,000 annually in the general revenue fund.

In June, I asked the Board of Aldermen to begin to think about putting a Use Tax before our voters in the Mayor's Report. Today, I ask you to consider a Use Tax as a tool to level the playing field with locally-owned businesses and large out-of-state retailers.

NEW Recycling Information



Recycling pilot/testing program

starting Friday, July 3rd thru Friday, August 28th!!! The Board of Aldermen

is discussing curbside recycling and asked to do a pilot/testing program to see if there would be more curbside recycling. The schedule for the next nine weeks will be:

July 3rd – Plastics, aluminum, tin

July 10th – Cardboard *only*

July 17th – Plastics, aluminum, tin

July 24th – Cardboard *only*

July 31st – **NO RECYCLING PICKUP**

August 7th – Plastics, aluminum, tin

August 14th – Cardboard *only*

August 21st – Plastics, aluminum, tin

August 28th – Cardboard *only*

Plastics include #1 thru #7. **Plastics, aluminum, and tin** need to be in the clear plastic recycling bags. If there is paper or cardboard in the recycling bags, they will **not** be picked up curbside that Friday. Friday curbside recycling for cardboard only is **NOT** to be in a plastic recycling bags, paper bags, or containers of any kind except cardboard. Just cardboard – paper, magazines, or any other fibrous materials will NOT be accepted.

Animal Tags/License



Pet tags are renewed in August of each year. An additional fee of \$25.00 is added at the time the license exceeds 60 days past one year. (on October 31st) The City

of Hallsville requires a license for all dogs & cats over the age of 6 months. Owners must show proof of rabies vaccination and pay of fee of \$3.00/year for pets spayed/neutered and \$5.00/year for pets not spayed/neutered.

CALL **3-1-1** and tell the non-emergency operator that you are within the city limits of Hallsville and either need an officer to call you back (leaving your phone number) or advise the operator of the issue you need addressed. The 3-1-1- operator will dispatch a Hallsville Officer.

Common Summer Ordinances to Remember and Follow!

What is the biggest issue in the summer besides grass?



Dogs. Yes, those lovable family members can be a nuisance to your neighbors! Check out the following Ordinances.

Section 205.170 Animals Running at Large Prohibited.

Except as provided for hereafter, any animal, fowl or reptile which is found to be running at large upon any street or public place of the City of Hallsville shall be taken up by the Animal Control Officer (or Police Officer) and impounded in the City Pound. Any animal impounded pursuant to this Section shall be released to its owner only upon payment of the prescribed fee to the Animal Control Officer (or Police Officer). Domestic cats are hereby exempted from the provisions of this Section, and, therefore, domestic cats shall not be subject to impoundment pursuant to this Article.

Section 205.180 Barking Annoying Dogs Prohibited.

No person shall own, keep or harbor any dog which by loud, continual or frequent barking, howling or yelping, shall annoy or disturb any neighborhood or any person, or which habitually barks at or chases pedestrians, or vehicles, whatsoever, to the annoyance of such pedestrian or drivers of such vehicles; provided, however, that this Section shall not apply to the City Dog Pound.

Section 205.270 Animal Waste.

- A. It shall be unlawful for a person who owns or is responsible for a dog to allow any such dog to defecate on any public property, street, sidewalk, or right-of-way or on the real property of another person.
- B. It is a specific defense to a charge of violating this Article that the person charged immediately remove any such excrement and properly dispose of it in a sanitary manner.
- C. Violation of this Article shall be a misdemeanor punishable by a fine of not less than ten dollars (\$10.00) nor more than five hundred dollars (\$500.00).

Section 205.280 Reimbursement of Costs for Collecting and Processing Dogs Running at Large.

- A. Upon the City collecting and processing a dog running at large in the City of Hallsville, the City

hereby assesses a fee for reimbursement of costs, to include but not be limited to the capturing, transporting, delivery, processing, holding, feeding, watering, kennel cleaning, vehicle cleaning, and ascertaining ownership to the owner of said dog.

- B. Boarding cost is fifty dollars (\$50.00) per day.
- C. These fees shall be calculated in addition to any fines and/or court costs assessed by the Circuit Court for any violation of the Animal Control Ordinances of the City of Hallsville, to include but not limited to dog running at large, unlicensed dog, and vicious dog

Section 205.300 Animal Neglect.

- A. A person commits the offense of animal neglect if he or she:
 1. Has custody or ownership of an animal and fails to provide adequate care; or
 2. Knowingly abandons an animal in any place without making provisions for its adequate care.
- B. All fines and penalties for a first finding of guilt under this Section may be waived by the court if the person found guilty of animal neglect shows that adequate, permanent remedies for the neglect have been made. Reasonable costs incurred for the care and maintenance of neglected animals may not be waived. This Section shall not apply to the provisions of Section 578.007, RSMo., or Chapter 272, RSMo.
- C. In addition to any other penalty imposed by this Section 578.009, RSMo., the court may order a person found guilty of animal neglect to pay all reasonable costs and expenses necessary for:
 1. The care and maintenance of neglected animals within the person's custody or ownership;
 2. The disposal of any dead or diseased animals within the person's custody or ownership;
 3. The reduction of resulting organic debris affecting the immediate area of the neglect; and
 4. The avoidance or minimization of any public health risks created by the neglect of the animals.

Recent Ordinances Passed

The newsletter will spotlight ordinances passed each quarter.
Bill#2020-7/Ordinance 381 An Ordinance Adopting and Enacting a New Code of Ordinances of the City of Hallsville.

At the July 13, 2020 Board of Aldermen Meeting **Bill#2020-5/Ordinance 379** An Ordinance Repealing and Replacing Chapter 340 Miscellaneous Driving Rules on Recreational Vehicles will be voted on.
