Happy Fall everyone! First, I would like to extend an invitation to all for the Hallsville Park Board's Trick-or-Treat in the Park on Saturday, October 23rd. In late September a release was made regarding the recycling site located at the Community Center, for those that did not see it, I wanted to share a brief summary.

"Your contact is timely as I have some news about the County Recycling Program I was wanting to share with you. The first thing that I would like to make you aware of is that the City of Columbia has informed us that they will not be providing hauling services for the County Recycling Program after November 30th 2021..."

"The County is in the process of putting out an RFP to find a hauler/processor or just a hauler. This process may not be finalized before the deadline and therefore the program may be suspended temporarily as we find a new provider. It should also be recognized that the reason we were with the City of Columbia for hauling in the first place is no one bid the last time we put this out for proposals and that if there isn't the proper level of qualified interest from vendors we may have no choice but to suspend the program indefinitely."

While this is not the news we wanted to hear, we will remain committed to assisting BCRM in the continuation of their recycling program. In the coming weeks we will see the RFP (Request for Proposal) published and if the county is able to obtain a new vendor. Thank you for your desire to recycle and understanding during this time.

Lastly, your eyes aren't playing tricks on you, our Police Department is wearing Pink in support of October being Breast Cancer Awareness Month. The Police Foundation of Hallsville hosted their First Annual Brews & Barbecue on October 2nd and will be continuing the sale of shirts and patches throughout the month to raise funds for Ellis Fischel Cancer Center at MU Health Care. Last year the Foundation made a donation in the amount of \$2,136.18 and we look forward to beating that this year with your help.

Trash

Trash pickup is **Wednesday**.
Trash should be at the curb the evening before.

Bulky trash pick-up is the third Wednesday of each month.

Bulky items include:

Furniture/beds, microwaves, or other sizable waste materials

Items not picked up:

Appliances: Refrigerators, ice makers, freezers, window air conditioners, stoves, washing machines, water tanks and construction debris.

Unacceptable Waste

Any type of special wastes without analysis and approval (asbestos, etc.); Any types of pesticides, poisons, cleaners, flammable liquids, dead animals, and hazardous waste.

Car and truck tires; Explosives; Hazardous wastes / PCB wastes; Infectious wastes; Lead acid car batteries; Medical wastes

Paints (oil based, enamel based, or lead based) latex or water-based paints are accepted if containers are opened and dried solid

Raw sewage; Waste oils (motor, hydraulic, etc.); Yard wastes (tree limbs, leaves, grass clippings, brush, etc.)
