1. INTRODUCTION

The City of Hallsville, Missouri is soliciting sealed Qualifications and Proposals from qualified engineering and construction firms for the repair and improvement of two intersections located within the Townsquare Subdivision:

- Lantern Drive & Ontario Drive
- Lantern Drive & Concert Avenue

This project will require the selected firm to evaluate, design, and construct repairs using either asphalt or concrete, based on engineering analysis. The proposal should include engineering services, cost estimates, and recommendations for the best solution for each intersection.

2. SCOPE OF WORK

A. Engineering Services

- Evaluate current conditions of both intersections.
- Assess structural, drainage, and subgrade conditions.
- Provide recommendation for asphalt vs. concrete repairs, including life-cycle cost comparison.
- Prepare stamped engineering drawings and specifications for the chosen solution.
- Provide construction oversight and quality assurance.

B. Construction

- Provide all labor, materials, and equipment for intersection repair and resurfacing.
- Manage traffic control during construction.
- Restore disturbed areas to original or better condition.

3. PROPOSAL CONTENT REQUIREMENTS

Part 1 – Qualifications (RFQ portion)

- Company background and history.
- Experience with similar municipal projects.
- References (minimum of three, with contact information).
- Proof of insurance and applicable licenses.

Part 2 – Proposal (RFP portion)

- Detailed approach to engineering and construction.
- Recommended material choice for each intersection.
- Itemized cost estimate, broken down into:
 1. Engineering/design
 2. Asphalt construction
 3. Concrete construction
 4. Traffic control
 5. Contingencies
- Project schedule, including milestones for design and construction.
- Warranty information.

5. EVALUATION CRITERIA

Submissions will be evaluated based on the following:

- Demonstrated qualifications and relevant experience (30%)
- Quality and feasibility of proposed approach (25%)
- Cost competitiveness and clarity of estimates (25%)
- Project schedule (10%)
- References and past performance (10%)

The City reserves the right to reject any or all submissions and to negotiate final scope and pricing with the selected firm.

6. GENERAL TERMS & CONDITIONS

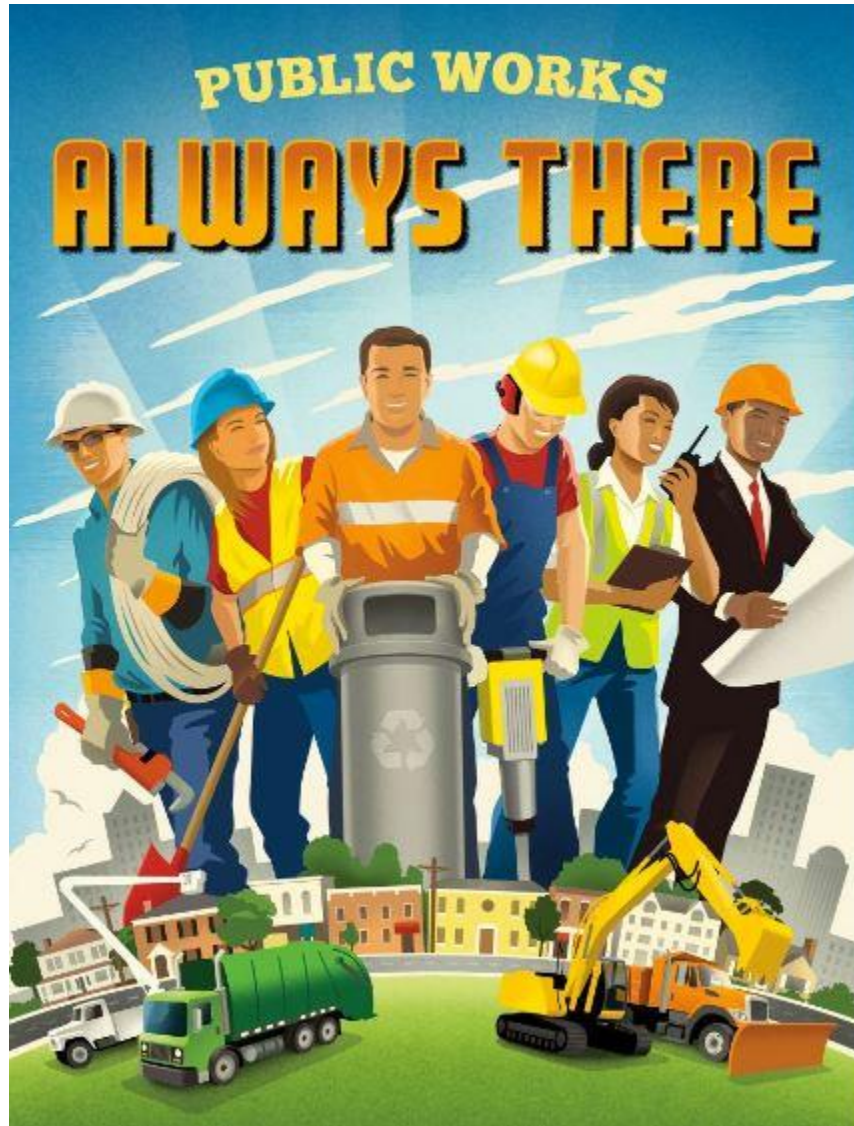
- All work must comply with applicable City, State, and Federal regulations.
