Update on trash service

Due to workers compensation's strong recommendations, Dayne's Waste Disposal is requiring the following change in the service they provide:

- Any trash can that is 45 gallons in size or bigger, they will no longer be dumping. However, if you choose to use these types of trash cans, that is fine, as long as everything is bagged in 13 gallon bags or larger and weigh less than 50 pounds. (Example - 3 or 4 trash cans that are 44 gallons in size or less will still be dumped without being bagged as long as it weighs less than 50 pounds)

All other services will remain the same. This will be effective March 1st, 2023. The last pick up in February, Dayne's will do one final dump on all the trash cans that are larger than 44 gallons and tag them with a tag advising "*ATTENTION This trash can is larger than 44 gallons. We will no longer be dumping any trash cans larger than 44 gallons. However, you may still use this container as long as everything is bagged in 13 gallon bags or larger and weighs 50lbs or less. Trash cans 44 gallons or less will still be dumped as normal as long as they don't exceed 50lbs. We apologize for any inconvenience.*"

Proposition 2

A Sales Tax on Retail Sales of Adult-Use Marijuana

The Hallsville Board of Aldermen passed an ordinance that would put a 3% sales tax on recreational marijuana sold within Hallsville city limits, subject to the approval of voters. The item will appear as **Proposition 2** on the April 4th ballot.

The Department of Revenue clarified that based on the constitutional language, a city and a county cannot "stack" the additional up to 3% local tax on recreational marijuana sales. A city and a county may both present ballot language for vote, an amount not to exceed 3% local sales tax on recreational marijuana. However, the tax collected from a customer is limited to the percentage passed and is based on the location of the recreational marijuana business (facility) and depends on if that facility is in the city or county area.

Example: If a facility is in a city, only the city can impose any (up to 3%) adult use tax. The county can only impose any adult use tax (up to 3%) on facilities located in the county.

If the county imposed 3% and the city does NOT impose any adult use tax, any facility located within the city will not charge any adult use tax, but if the facility is outside the city, the county will charge 3% and that will be distributed to the county only.

The adult use tax (up to 3%) imposed by the city or county is in addition to the 6% recreational marijuana tax and all other applicable sales tax currently in place for the political subdivision where the dispensary is located.

There are currently no dispensaries with plans to open in Hallsville, but passage of the tax would position the City to capture additional revenue if or when a dispensary opens in Hallsville.
