Trash Service Update

The City received an update from Dayne's Waste Disposal. Most residents that were tagged (for bags only) didn't read the tag or maybe didn't understand it and were still not bagging their trash. To clarify, <u>NO LOOSE</u> trash in the trash can, everything in the trash can must be bagged. The bag cannot weigh more than 50 pounds and cannot be smaller than 13 gallon bags.

Proposition 911 A Public Safety Sales Tax

What does a YES vote mean?

It would result in a 1% sales tax for Public Safety. It would generate approximately \$120,000.00 each year for Public Safety.

How could the Public Safety Tax be used?

If approved, the Public Safety Sales Tax could be used for the following:

The hiring of quality officers to provide the citizens of Hallsville 24 hour/7 days a week police coverage.

The purchase of needed equipment to increase emergency response capability and capacity.

Ongoing training.



Sample Ballot language:

"Shall the City of Hallsville, Missouri, impose a sales tax of one percent (1%) for the purpose of improving public safety?"
