# Recreational Vehicle Permit Application

Current definitions:



**Utility vehicle:** Used exclusively for off-highway use which is more than 50 inches but not more than 67 inches in width, with an unladen dry weight of 2,000 lbs. or less, traveling on 4 or 6 wheels, to be used primarily for landscaping, lawn care or maintenance purposes.



**Golf carts:** Manufactured and designed for operation on a golf course for sporting or recreational purposes.



**Recreational Off-Highway Vehicle:** Used exclusively for off-highway use which is more than 50 inches but no more than 67 inches in width, with an unladen dry weight of 2,000 lbs. or less, traveling on 4 or more non-highway tires and which may have access to ATV trails.

*Notice to applicant: Please complete legibly and completely. The permit is good from September 1<sup>st</sup> to August 31<sup>st</sup> of the following year. You and your UTV, Golf Cart, or Recreational Off-Highway Vehicle must meet all inspection requirements including safety inspection, a valid driver license and current proof of insurance on the recreational vehicle.*
